The Top 25 Auditors maintained market share during January 2017 and provide administration services to over 93% of the marketplace!

- **Noteworthy Headlines from the Top 5 Auditors³**
 - E&Y assets increased 7% in Securitized Asset Funds and the number of funds increased 6%
 - **DELOITTE** assets increased 5% in Quant and the number of funds increased 3%
 - KPMGRK assets increased 2% in Debt Diverse and the number of funds increased 1%
 - GRANT THORNTON assets increased 2% in Debt Diverse and the number of funds increased 2%

- **Noteworthy Headlines from the Top 6-25 Auditors⁴**
 - **RSM** assets increased 2% in Other and the number of funds increased 1%
 - COHN RESNICK assets increased 10% in Equity-Long/Short and the number of funds increased 15%
 - BDO SEIDMAN assets in Real Estate increases by 8% and the number of funds increased 20%
 - PATKE ASSOCIATES assets in Emerging Markets increased 107%
