The Top 25 Auditors maintained market share during February 2017 and provide administration services to over 94% of the marketplace!

➤ **Noteworthy Headlines from the Top 5 Auditors³**

- E&Y assets increased in Distressed-Debt by 67% and the number of funds increased 65%
- **PRICE WATERHOUSE COOPERS** increased its assets in Securitized Asset Funds by 38% and the number of funds increased 24%
- **DELOITTE** assets increased 19% in Debt-Diverse and the number of funds increased 23%
- KPMGRK assets increased 9% in Debt-Diverse and the number of funds increased 4%
- GRANT THORNTON assets increased 45% in Securitized Asset Funds

➤ **Noteworthy Headlines from the Top 6-25 Auditors⁴**

- **RSM** assets increased 38% in Multi-Strat and the number of funds increased 17%
- BAKER TILLEY VIRCHOW KRAUSE assets increased 114% in Hedge Funds and the number of funds increased 123% due to winning \$7.8B of MIO PARTNERS business
