Top 25 Alternative Fund Auditor League Tables February 28, 2017 through February 28, 2018

The alternative asset management industry continues to grow. New and existing Advisers continue to launch funds and asset growth is being helped by more robust equity markets. Administrators continue to jockey for position and market share.

The Big 4 Accounting firms¹ share of funds audited declined from 74% to 73% while their share of private fund assets remained at 91% and were named the fund's auditor in 50% of 7,476 of New Fund Launches

- > Noteworthy Headlines from the Big 4 Auditors
 - PRICE WATERHOUSE COOPERS funds increased 6% and assets increased 13%
 - **DELOITTE** funds increased 5% and assets increased 10%
 - E&Y funds increased 6% and assets increased 8%
 - **KPMGRK** funds increased 1% and assets 11%
- ➤ Noteworthy Headlines from the Top 5-25 Auditors²
 - MOSS ADAMS funds increased 19% and assets increased 21%
 - PLANTE MORAN funds increased 28% and assets increased 27%
 - FRANK RIMERMAN CO funds increased 61% and assets increased 48%
 - SPICER JEFFRIES funds increased 26% and assets increased 18%
 - BAKER TILLEY VIRCHOW KRAUSE funds increased 57% and assets increased 49%
