Best and Worst Performing Peer Groups

- Admins ranked 11-25 registered the highest growth in funds
 - Funds increased 13.61%, or 6.85x the market
 - Market share increased from 11.47% to 12.78%
 - An increase of 11.40%
- Admins ranked >25 registered the smallest growth in funds
 - Funds decreased 0.95%, or -0.48x the market
 - Market share decreased from 23.75% to 23.07%
 - A decrease of 2.88%

 - AuA increased 14.73%, or 1.18x the market
 - Market share increased from 23.76% to 24.24%
 - An increase of 2.04%
- Admins ranked 6-10 registered the lowest AuA growth
 - AuA increased 4.42%, or 0.36x the market
 - Market share decreased from 9.62% to 8.93%
 - A decrease of 7.13%
