Best and Worst Performing Peer Groups

- Admins ranked 11-25 registered the highest growth in funds
 - Funds increased 14.33%, or 3.24x the market
 - Market share increased from 11.81% to 12.93%
 - An increase of 9.48%
- Admins ranked >25 registered the smallest growth in funds
 - Funds increased 1.61%, or 0.36x the market
 - Market share decreased from 23.66% to 23.02%
 - A decrease of 2.70%

 - AuA increased 14.40%, or 1.28x the market
 - Market share increased from 10.95% to 11.26%
 - An increase of 2.83%
- Admins ranked >25 registered the lowest AuA growth
 - AuA increased 6.60%, or 0.59x the market
 - Market share decreased from 12.21% to 11.70%
 - A decrease of 4.18%
