Best and Worst Performing Peer Groups

- Admins ranked 6-10 registered the highest growth in funds
 - Funds increased 11.55%, or 2.49x the market
 - Market share increased from 6.79% to 7.24%
 - An increase of 6.60%
- Admins ranked 1-5 registered the smallest growth in funds
 - Funds increased 0.84%, or 0.18x the market
 - Market share decreased from 15.14% to 14.59%
 - A decrease of 3.63%

 - AuA increased 16.80%, or 1.14x the market
 - Market share increased from 11.44% to 11.64%
 - An increase of 1.78%
- Admins ranked 1-5 registered the lowest AuA growth
 - AuA increased 12.76%, or 0.86x the market
 - Market share decreased from 24.00% to 23.58%
 - A decrease of 1.75%
