- Admins ranked 6-10 registered the highest growth in funds
 - Funds increased 10.80%, or 2.44x the market
 - Market share increased from 6.87% to 7.29%
 - An increase of 6.10%
- Admins ranked 1-5 registered the smallest growth in funds
 - Funds increased 1.29%, or 0.29x the market
 - Market share decreased from 15.23% to 14.77%
 - A decrease of 3.01%

 - AuA increased 14.55%, or 1.30x the market
 - Market share increased from 10.37% to 10.68%
 - An increase of 3.01%
- Admins ranked 6-10 registered the lowest AuA growth
 - AuA increased 6.87%, or 0.61x the market
 - Market share decreased from 8.75% to 8.41%
 - A decrease of 3.90%
